**RESOLUTION APPROVING THE AMOUNT TO BE SPENT  
BY THE WINSTON-SALEM/FORSYTH COUNTY  
BOARD OF EDUCATION TO ACQUIRE REAL PROPERTY  
TO BE USED FOR FUTURE IMPROVEMENTS AT THE  
PAISLEY IB MAGNET/LOWRANCE SCHOOL PROJECT SITE  
(TAX BLOCK 0909, LOT 106E (PIN 6826-72-9456.00))**

**WHEREAS**, the provisions of N.C.G.S. 115C-426(f) require the approval by the Board of County Commissioners as to the amount to be spent by the Board of Education for school sites prior to the execution of a contract by the Board of Education for the purchase of a site or the expenditure of funds therefor; and

**WHEREAS**, on May 23, 2017, the Winston-Salem/Forsyth County Board of Education adopted a Resolution to exercise an Option to Purchase Real Estate relating to real property consisting of approximately .50 acres owned by the City of Winston-Salem, to be used for future improvements at the Paisley IB Magnet/Lowrance School Project site, which property is located off Thurmond Street, in Winston-Salem, N.C. and is further described as Tax Block 0909, Lot 106E (PIN 6826-72-9456.00), on the Forsyth County Registry, subject to approval by the Forsyth County Board of Commissioners of the amount to be spent on the site as required by law; and

**WHEREAS**, the Winston-Salem/Forsyth County Board of Education requests that the Forsyth County Board of Commissioners approve Forty-One Thousand Nine Hundred and 00/100 Dollars (\$41,900.00) as the amount to be spent to purchase the above-described real property.

**NOW, THEREFORE, BE IT RESOLVED** that the Forsyth County Board of Commissioners hereby approves the total amount of Forty-One Thousand Nine Hundred and 00/100 Dollars (\$41,900.00) to be spent by the Winston-Salem/Forsyth County Board of Education for the purchase of approximately .50 acres owned by the City of Winston-Salem, which property is located off Thurmond Street, in Winston-Salem, N.C. and is further described as Tax Block 0909, Lot 106E (PIN 6826-72-9456.00), on the Forsyth County Registry and to be used for future improvements at the Paisley IB Magnet/Lowrance School Project site.

At its meeting on May 23, 2017, the Winston-Salem/Forsyth County Board of Education approved, subject to approval of the purchase price by the Forsyth County Board of Commissioners pursuant to N.C.G.S. § 115C-426, the purchase of real property owned by the City of Winston-Salem, such property known as a portion of Block Lot 0909106E (PIN 6826-72-9456.00), Forsyth County Registry, for a purchase price of \$41,900.00.

The Board of Education requires such property for construction and expansion of the new Paisley IB Magnet/Lowrance Middle School projects.

**RESOLUTION OF THE  
WINSTON-SALEM/FORSYTH COUNTY BOARD OF EDUCATION  
EXERCISING OPTION TO PURCHASE REAL ESTATE OWNED BY  
THE CITY OF WINSTON-SALEM**

WHEREAS, on or about May 9, 2017, the Board of Education approved in closed session the negotiation of the purchase price for a .50 tract of land located adjacent to the Paisley IB Magnet school property located off Thurmond Street, owned by the City of Winston-Salem identified and identified as Block Lot 0909106E (PIN 6826-72-9456);

WHEREAS, the tract of land has been improved with three tennis courts which are in dilapidated condition and have not been used by the City for several years;

WHEREAS, the Board of Education believes the tract or parcel of land owned by the City of Winston-Salem is a proper, necessary and suitable site for the construction and expansion of school facilities at the new Paisley IB Magnet/Lowrance school project;

WHEREAS, the purchase price for the real property described hereinabove is Forty-One Thousand, Nine Hundred and No/100 Dollars (\$41,900.00);


WHEREAS, N.C.G.S. §160A-274 authorizes the sale or purchase of any interest in real or personal property between governmental units with or without consideration;

WHEREAS, the Board hereby approves and authorizes the purchase of said property, subject to approval by the Board of County Commissioners of Forsyth County pursuant to N.C.G.S. § 115C-426.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Winston-Salem/Forsyth County Board of Education hereby approves the purchase of such property known as Block Lot 0909106E (PIN 6826-72-9456), Forsyth County Registry, and being .50 acres, more or less, subject to approval by the Board of County Commissioners of Forsyth County pursuant to N.C.G.S. § 115C-426, and authorizes staff to execute documents required to complete said purchase.
