SUMMARY OF INFORMATION:

This item authorizes an application to be submitted to the North Carolina Public School Building Capital Fund for State funds in the amount of \$244,886.25 to finance the Southwest Elementary School Roofing Project. The local matching funds of \$81,628.75 are to be designated for the project in the 2016 WS/FC Schools Capital Maintenance 2/3rds Bonds Capital Projects Ordinance. An amendment to the 2016 WS/FC Schools Capital Maintenance 2/3rds Bonds Capital Projects Ordinance is necessary to authorize the transfer of these local matching funds to the State Public School Building Capital Fund Special Revenue Fund.

RESOLUTION RATIFYING AND AUTHORIZING A JOINT APPLICATION WITH WINSTON-SALEM/FORSYTH COUNTY SCHOOLS FOR FUNDS FROM THE NORTH CAROLINA PUBLIC SCHOOL BUILDING CAPITAL FUND AND DESIGNATING LOCAL MATCHING FUNDS

WHEREAS, the provisions of N.C.G.S.115C-546.1(a) created the Public School Building Capital Fund to assist county governments in meeting their public school building capital needs; and

WHEREAS, monies in the said Fund shall be used for capital outlay projects including the planning, construction, reconstruction, enlargement, improvement, repair or renovation of public school buildings and for the purchase of land for public school buildings; and

WHEREAS, monies in the Fund shall be matched on the basis of one dollar of local funds for every three dollars of State funds;

NOW, THEREFORE, BE IT RESOLVED that the Forsyth County Board of Commissioners hereby ratifies and authorizes the Chairman and the Clerk to the Board to execute, on behalf of Forsyth County, a joint application with Winston-Salem/Forsyth County Schools in the amount of \$244,886.25 from the North Carolina Public School Building Capital Fund, for the Southwest Elementary School Roofing Project, subject to a pre-audit certificate thereon by the County Chief Financial Officer, if applicable, and approval as to form and legality by the County Attorney.

BE IT FURTHER RESOLVED that local matching funds in the amount of \$81,628.75 from 2016 local bond funds are hereby designated for the Southwest Elementary School Roofing Project, subject to a preaudit certificate thereon by the County Chief Financial Officer, if applicable, and approval as to form and legality by the County Attorney.

BE IT FURTHER RESOLVED that this resolution ratifying interlocal cooperation between Forsyth County and the Winston-Salem/Forsyth County Board of Education is hereby spread upon the minutes of the Forsyth County Board of Commissioners.
