Forsyth County Department of Public Health, as a mentor to Davidson County, is eligible to be reimbursed for \$10,000 in items that benefit the Forsyth County Department of Public Health vector program. RESOLUTION AUTHORIZING ACCEPTANCE OF UP TO \$10,000 IN GRANT FUNDS FOR PARTICIPATION IN THE VECTOR CONTROL COLLABORATIVE (VCC), ESTABLISHED BY THE NATIONAL ASSOCIATION OF COUNTY AND CITY HEALTH OFFICIALS (NACCHO) AND THE CENTERS FOR DISEASE CONTROL AND PREVENTION TO FORSYTH COUNTY DEPARTMENT OF PUBLIC HEALTH

WHEREAS the National Association of County and City Health Officials (NACCHO) and the Centers for Disease Control and Prevention have established the Vector Control Collaborative (VCC) to match local vector control programs with demonstrated expertise with vector control programs currently looking for guidance, tools and resources, and recommendations to build program capacity;

WHEREAS Davidson County was identified as a mentee through the VCC and identified Forsyth County as the mentor;

WHEREAS as the identified mentor, Forsyth County Department of Public Health is eligible for reimbursement of \$10,000 used for purchases that benefit the Forsyth County Department of Public Health Vector Program; and

WHEREAS Forsyth County Department of Public Health will be reimbursed for authorized purchases made by February 28, 2020;

NOW, THEREFORE, BE IT RESOLVED, by the Forsyth County Board of Commissioners that the County Manager and the Clerk to the Board are hereby authorized to (1) expend up to \$10,000 in purchases authorized under the Grant, and (2) to receive \$10,000 from the Vector Control Collaborative (VCC), established by the National Association of County and City Health Officials (NACCHO) and the Centers for Disease Control and Prevention.
