**SUMMARY OF INFORMATION:**

Bids were received July 26, 2019, for the purchase of twelve 2019 all-wheel drive Dodge Charger Police Pursuit Vehicles (PPV's) per bid specifications. Summary of bids received follows:

**RESOLUTION AWARDING A CONTRACT FOR THE PURCHASE OF  
2019 DODGE CHARGER POLICE PURSUIT VEHICLES  
(GENERAL SERVICES DEPARTMENT)**

**WHEREAS** bid invitations for twelve 2019 Dodge Charger police pursuit vehicles to be utilized by the Forsyth County Sheriff's Department were issued directly to a total of thirteen qualified businesses, as well as advertised on the City-County Purchasing website, the NC State Purchasing website, and the Winston-Salem Journal; and

**WHEREAS** after due advertisement, bids were received and publicly opened by the City/County Purchasing Department at 12:00 Noon, on Friday, July 26, 2019, for the purchase of twelve 2019 all-wheel drive Police Pursuit Vehicles (PPV'S) per bid specifications at the request of the Forsyth County General Services Department and intended for use by the Forsyth County Sheriff's Department and the following bids were received:

**WHEREAS** the bid offered by Performance Automotive Group, Inc. is provided through the North Carolina Sheriff's Association Group Purchasing Program, a formally organized competitive bidding group purchasing program that offers discount prices to public agencies, compliant with N.C.G.S. 143-129(e)(3); and

**WHEREAS** it is the recommendation of the County Manager, the County General Services Director, and the City/County Purchasing Director that a contract for the purchase of twelve 2019 all-wheel drive Dodge Charger PPV's per bid specifications in the amount of \$24,224 each be awarded to Performance Automotive Group, Inc. for a total amount of \$290,688; and

**WHEREAS** the County Chief Financial Officer has determined sufficient funds are available to cover the cost of these contracts.

**NOW, THEREFORE, BE IT RESOLVED**, by the Forsyth County Board of Commissioners, that a contract for the purchase of twelve 2019 all-wheel drive Dodge Charger PPV's per bid specifications in the amount of \$24,224 each is hereby awarded to Performance Automotive Group, Inc. in the total amount of \$290,688 and that all other bids are hereby rejected.

**BE IT FURTHER RESOLVED**, that the County Manager and Clerk to the Board are hereby authorized to execute a contract, on behalf of Forsyth County, with Performance Automotive Group, Inc. for the purchase of twelve 2019 all-wheel drive Dodge Charger PPV's consistent with the terms outlined herein, subject to a pre-audit certificate thereon by the County Chief Financial Officer, if applicable, and approval as to form and legality by the County Attorney.
