**SUMMARY OF INFORMATION:**

The proceeds from 2020 General Obligation Refunding Bonds sale will be used to redeem the callable bonds being refunded, the 2010A Public Improvement Two-Thirds Bonds and the 2010C Public Improvement Build America Bonds. The proceeds will also be used to pay any debt issuance costs associated with the recent sale.

The FY 2019-2020 Debt Service Fund needs to be amended to appropriate the proceeds totaling \$77,484,113.85 for both purposes.

**EXPLANATION:**

Of the \$77,484,113.85 in proceeds from 2020 General Obligation Refunding Bonds sale, \$77,220,000 will be used to redeem the callable bonds being refunded, the 2010A Public Improvement Two-Thirds Bonds and the 2010C Public Improvement Build America Bonds. This redemption will fully retire both of these bond series. The remaining \$264,113.85 will be used to pay any debt issuance costs associated with the recent sale.
