SUMMARY OF INFORMATION:

This is a budget ordinance amendment to appropriate funds from the Center for Disease Control-Epidemiology and Laboratory Capacity (CDC-ELC) Cooperative Agreement for the Department of Public Health in the amount of \$1,234,016. These funds are to be used by the local health department for COVID-19 related activities such as staffing, infection control, testing and tracing. The funds expire after 30 months.

**RESOLUTION AUTHORIZING EXECUTION OF AN AGREEMENT BETWEEN
FORSYTH COUNTY AND THE NORTH CAROLINA DEPARTMENT OF HEALTH
AND HUMAN SERVICES TO ACCEPT CENTER FOR DISEASE CONTROL-
EPIDEMIOLOGY AND LABORATORY CAPACITY FUNDS**

WHEREAS the North Carolina Department of Health and Human Services will distribute Center for Disease Control-Epidemiology and Laboratory Capacity (CDC-ELC) funds to counties in the State including an allocation of \$1,234,016 to Forsyth County; and

WHEREAS County will use such funds to mitigate the impact of Covid-19 by paying for resources that may include staffing, improved infection control, testing and contact tracing, improving IT infrastructure and data sharing as it relates to Covid-19 response as well as hiring of contact tracers, and outreach to historically marginalized populations;

NOW, THEREFORE, BE IT RESOLVED, that the Forsyth County Board of Commissioners hereby authorizes the Chairman or County Manager and Clerk to the Board to execute, on behalf of Forsyth County, an agreement with the North Carolina Department of Health and Human Services, to accept Center for Disease Control-Epidemiology and Laboratory Capacity funds, in an amount of \$1,234,016, subject to a pre-audit certificate thereon by the County Chief Financial Officer, if applicable, and approval as to form and legality by the County Attorney.
