
**COUNTY MANAGER'S RECOMMENDATION OR COMMENTS:** Recommend Approval

### SUMMARY OF INFORMATION:

In FY 2013-2014, the demand for screening and diagnostic mammography services at the Forsyth County Department of Public Health exceeded forecasted amounts. An amendment to the agreement with Forsyth Medical Center Imaging for mammography services was signed in late June 2014, however, the amended agreement total exceeded \$50,000 and requires approval by the Forsyth County Board of Commissioners, which did not occur before the end of the 2013-2014 fiscal year.

The Forsyth County Board of Commissioners, on behalf of the Forsyth County Department of Public Health, hereby acknowledges the services for the breast and cervical cancer control program have been performed by Forsyth Medical Center Imaging and the Board hereby authorizes payment by Forsyth County of \$14,192.42 to Forsyth Medical Center Imaging for services performed during fiscal year 2013-2014. This payment is authorized on the basis of quantum meruit for the reasonable and just value of services furnished and acknowledged as a benefit to the County and its Department of Public Health and for which the County received the benefits with the expectation of payment being made for these services.

**WHEREAS**, Forsyth County, on behalf of its Department of Public Health, entered into a contract with Forsyth Medical Center Imaging to provide breast and cervical cancer screening and diagnostic services; and
