SUMMARY OF INFORMATION:

Forsyth County Cooperative Extension Service has received \$16,010 from the North Carolina Agricultural Foundation, Inc. for construction of a fence around the Tanglewood Park Arboretum and Gardens.

The cost of this project is \$60,391.58. The Cooperative Extension Service received a grant in the amount of \$30,000 for this project in November 2015. With this additional funding, \$14,381.58 will still be needed to complete the project.

The Forsyth County Parks and Recreation Department proposes to use capital repair and maintenance funds to fund the remaining portion of this project.

**RESOLUTION AUTHORIZING EXECUTION OF NECESSARY DOCUMENTS TO
RECEIVE FUNDS FROM THE NORTH CAROLINA AGRICULTURAL
FOUNDATION, INC. FOR CONSTRUCTION OF A FENCE AROUND THE
ARBORETUM AND GARDENS AT TANGLEWOOD PARK
(FORSYTH COUNTY COOPERATIVE EXTENSION SERVICE)**

WHEREAS, the Forsyth County Cooperative Extension Service is raising money to construct a \$60,391.58 fence around the Tanglewood Park Arboretum and Gardens; and

WHEREAS, the Cooperative Extension Service received a \$30,000 grant for this project in November 2015 and has now received \$16,010 in funding from the North Carolina Agricultural Foundation, Inc., which funds need to be received and appropriated; and

WHEREAS, the Forsyth County Parks and Recreation Department proposes to use capital repair and maintenance funds to fund the remaining portion of the project;

NOW, THEREFORE, BE IT RESOLVED that the Forsyth County Board of Commissioners hereby authorizes the Chairman or County Manager and the Clerk to the Board to execute necessary documents, on behalf of Forsyth County, to receive funds in the amount of \$16,010 from the North Carolina Agricultural Foundation, Inc. for construction of a fence around the arboretum and gardens at Tanglewood Park, subject to a pre-audit certificate thereon by the County Chief Financial Officer, where applicable, and approval as to form and legality by the County Attorney.
