

2019 SWIM LESSONS - Tanglewood REGISTRATION INFORMATION

- The swim lesson program will be conducted by **Carolina Pool Management, Inc.**
- Swimmers are encouraged to participate in an **evaluation class** before being assigned a class level.
- Class size will be a **maximum of 6 students** per instructor.
- A class must have a **minimum of 3 students** enrolled for it to be held.
- Each session will be made of **four (4) 30 minute classes**.
- Classes will meet **Tuesday and Thursday for two weeks**
- **Five (5) Group Swim Sessions (each session includes 2 weeks of Tuesday and Thursday lessons)**
 - **Session 1:** **June 10 - June 21** Tuesday & Thursday 9:30am – 10:00am
 - **Session 2:** **June 24 – July 5** Tuesday & Thursday 9:30am – 10:00am
 - No class July 4th – this class will be moved to Friday July 5th**
 - **Session 3:** **July 8 – July 19** Tuesday & Thursday 9:30am – 10:00am
 - **Session 4:** **July 22 – August 2** Tuesday & Thursday 9:30am – 10:00am
 - **Session 5:** **August 5 – August 16** Tuesday & Thursday 9:30am – 10:00am

Class Descriptions

- Tadpoles** Students must be at least 3 years old. This class emphasizes water orientation, basic water safety, and developing a comfort level with the water. Lessons will teach basic skills to develop safe swimmers.
- Guppies** Students must be at least 3 years old. Students must be able to swim at least 3 feet independently and show comfort in the water. Lessons will teach basic skills to develop safe swimmers.
- Beginner** Students must be comfortable in the water. Student must swim independently for 6 feet. Basic skills for freestyle and backstroke are taught.
- Intermediate** Students must be able to swim a minimum of 10 yards of both Beginner freestyle and backstroke. Students will begin working on the basic skills for the three strokes (backstroke, breaststroke & freestyle).

FEE STRUCTURE

- **Group Lessons** \$55 per session + \$5 registration fee = **\$60 per session**

Dear Parent/Guardian:

Thank you for taking an interest in our swim lesson program. We hope the following will answer any questions you may have.

We believe that with patience, positive encouragement, and frequent repetition of skills, your child will have a happy, safe, and successful swimming experience. It is normal for a child to remain in the same level for several sessions, especially at the Pre-School level. It is not realistic to expect that a pre-school non-swimmer will “learn to swim” in one session of lessons. Each child that participates is a success. Repetition of skills is important and we encourage you to practice with your child.

To serve you better we have developed a few guidelines:

1. Most children respond better to their teacher and learn more when their parents are out of sight. Because of this, we ask that you leave the pool area while your child’s class is in session.
2. If after one lesson we find that you child is not ready for the swimming lessons, we will remove the child from the class roll, recommend that the child start lessons when they are older, and refund the full class fee to you.
3. If a class is canceled due to weather, it will be rescheduled at the earliest opportunity.
4. No class will be made up due to participant illness.
5. If your check is returned for insufficient funds, you will owe the amount for swim lessons and a \$30 Insufficient Funds Fee
